Meeting was held at Kootenai County Licensing Building located at 451 Government Way, Coeur d'Alene, ID 83815 due to the NRCS office still being closed due to COVID-19.

Meeting called to order by Chairman Ed Pommerening at 9:00 a.m.

Linda Ely moved and Bob Flagor seconded the motion to approve the December 2020 minutes. Motion Carried.

Laurin Scarcello moved and Linda Ely seconded the motion to approve the December 2020 financial reports. **Motion Carried**.

Aubrey Hoxie, NRCS was not in attendance but did provide a handout of the updates from her agency.

Brad Shelton, ISWCC was not in attendance and he provided a handout of the updates.

Karla Freeman, District Administrator updated the ongoing projects:

Karla had Wes Evans and John Minichino Jr. take the oath of office and welcomed the new Supervisors to the board.

Wolf Lodge Creek Reach #3 – This project was completed at the end of November 2020. We have one final invoice to pay out to Glacier Excavating. There will be spring clean- up on both land owners property that will be done by Sandy and Paul Schlepp and then have one invoice left to payout for this. Karla is currently working on final reports to close out the Restoration Partnership Grant as well as the 319 BMP Grant for DEQ.

Castle Rock Ranch – The Albert Walsh project through Restoration Partnership Grant is almost complete. There will be one more spring planting and then this grant will be completed.

Karla updated the board on the conference call the was had on Tuesday January 19, 2021 with the Shoshone County Commissioners to update on the 319 Grant North Fork of the Coeur d'Alene River. Bill Lillibridge, ISWCC will be the engineer on the project and he will be starting the designs so we can move forward with the permitting process. Shoshone County commissioners are excited to have a project in the community.

Karla updated that the yearly audit was complete and reminded the board that there was an electronic copy emailed to everyone. This audit has already been uploaded to the State site.

Karla updated that the District had received the \$6,000 allocation from Kootenai County as requested last year from the Kootenai County commissioners.

Karla updated on the tree seedling program. At the time of the board meeting, we had 3300 trees left to sell.

Karla also updated that after the February 2021 board meeting, all supervisors would need to go into the Idaho Central Credit Union and sign new signature cards since we now have two new members on the board. This would have to take place after the board meeting so the January 2021 meeting minutes could be approved, and this would need to be taken in to the branch.

Emily Black and Betty Mobbs with the Pan Handle Farm Corridor requested time to present a letter to request sponsorship for the program. Since sponsoring last year, the Pan Handle Farm Corridor has signed up additional farmers. They need additional funding to produce a new brochure, and fund new marketing methods. the District decided to sponsor the program for another year, we would also be listed as a source to sell the tree seedlings. Emily and Betty had handouts that included additional information about the program.

Laurin Scarcello moved and Linda Ely seconded the motion to sponsor the Pan Handle Farm Corridor for an additional year. **MOTION CARRIED.** 

Next on the agenda was the new truck lease s and lease turn in. Karla presented four quotes from local dealership on the truck options we have. There was discussion on the best truck that would fit the needs of the boat station manager. The leased truck we currently have is a Dodge Ram 1500 and will need to be turned in by February 21,2021. Bob Flagor, Ed Pommerening and Karla will arrange to get the truck back to Dave Smith for turn in prior to the deadline.

Wes Evans moved and Linda Ely seconded the motion to go with the 2020 Dodge Ram 1500 from Dave Smith. **MOTION CARRIED.** 

Next on the agenda was appointing Stan Thornton as an Associate Supervisor.
